As of April 1, 2012, Dr. Stefan Spindler is responsible for the Business Unit Mobile Applications and Engineering. He has been a member of the Executive Board at Bosch Rexroth AG since July 1, 2010, and was previously Head of the Business Unit Renewable Energies.

Spindler studied Mechanical Engineering at the Technical University Munich and received his doctorate in 1992 simultaneous to his work at Motoren- und Turbinen-Union Friedrichshafen GmbH. Following a three-year period as Chief Engineer in the USA, he assumed responsibility for Global Marine After Sales Service as Department Head upon his return to Germany.

In 2000, Dr. Spindler joined Liebherr Machines Bulle S.A. in Switzerland, where he served as the Engines Product Division Head and Acting Chief Technology Officer. In 2002, he was appointed as a Board Member at MAN Diesel SE, where he was responsible for the Power Plants and Marine Medium Speed business divisions. Prior to joining the Bosch Rexroth AG Executive Board, Dr. Spindler had assumed cross-divisional responsibility for Technology, Quality, as well as Product and Technology Development in 2009 as the Chief Technology Officer on the Executive Board of the new MAN Diesel & Turbo SE unit following the merger of MAN Diesel and MAN Turbo.
